APPLICATION FOR BASIC ASSOCIATESHIP

I, the undersigned, apply to become a Basic Associate of British and Irish Association of Zoos & Aquariums (BIAZA).

(Name in Capitals)

I recognise the growing contribution to the conservation of certain endangered species, to education, to our knowledge and understanding of animals, and to public recreation, in modern zoos;

I accept that all zoos and private collections have the duty to co-operate fully, eschewing the motive of financial gain in excess of reasonable recovery of fairly incurred costs, in the science-based management of the species in their care;

I recognise the need to maintain high standards of animal welfare in zoos and private collections;

I acknowledge that whilst displays, including advertising, which involve the animals demonstrating their natural abilities are acceptable, those which rely on unnatural exaggeration and on caricatures of the animals' behaviour do not contribute to the role of responsible zoos outlined above and are therefore out of keeping with associateship;

I accept that it is desirable that those animals introduced into zoos and private collections should have been bred in other responsible collections. When animals are being introduced into collections from the wild, I accept that this should be done only with the explicit approval of the relevant conservation authorities of the countries of origin and also that they have been imported legally and for the express purpose of involvement in co-operative breeding programmes;

I condemn indiscriminate generalised attacks on responsible zoological collections and while a Basic Associate I undertake to raise any adverse criticism I may have of BIAZA, or of its Member zoos, or of private collections associated with BIAZA, in a private and confidential manner with BIAZA;

I agree not to use my basic associateship to further personal or professional matters;

I acknowledge that my basic associateship may be terminated, without reason being given, by the Council of BIAZA within 12 months of my joining. Thereafter, should BIAZA consider my associateship to be incongruent or detrimental to BIAZA, it may terminate my

associateship, giving its reason, subject to my right of appeal to a committee of the Council which decision shall be final;

I have read the *Constitution* of British and Irish Association of Zoos & Aquariums;

I agree to pay such rates of subscription as shall from time to time be prescribed by the Council of BIAZA;

I agree to abide by the terms and spirit of this declaration.
